About **TSPI MBAI**

TSPI Mutual Benefit Association, Inc. (TSPI MBAI) is the microinsurance arm of TSPI NGO. It provides microinsurance benefits to the employees, clients and their dependent family members in case of death, accident and illness. It was registered as a non-stock, non-profit organization on August 31, 2005. It was granted a license by Insurance Commission on December 22, 2006.

Vision

To see people live Christ-centered lives with dignity, sufficiency, integrity and hope demonstrating this through love and service in their families and communities.

Mission

We are one with TSPI in providing opportunities to experience fullness of life in Christ to individuals, families and communities that we serve by giving access to microinsurance products and social development services.



Microinsurance Products

TSPI MBAI's insurance plans are called "KAAGAPAY PLANS". The term "kaagapay" is a combination of the Filipino words "ka" meaning associate/fellow and "agapay" which means to assist or to be by one's side. Members can avail the following:

1. Kaagapay Basic Life Insurance Plan (BLIP)

It is a mandatory insurance with a premium of P240 per annum. The coverage includes death and accidental death benefits, accidental dismemberment/disablement and total and permanent disability. It covers both the member and qualified dependents. Members have equity value equivalent of P120 or 50% of the premium.

2. Kaagapay Life Plus Insurance Plan (Life Plus)

It is an optional plan with a premium of P240 per annum and a benefit twice as that of BLIP. It can be availed up to 5 units per member at any given time.

3. Kaagapay Life Max Insurance Plan (Life Max)

It is an optional plan with a premium of P650 per annum. The coverage includes death, accidental death, hospital income and total and permanent disability benefits. It can be availed up to 5 units per member at any given time.

4. Kaagapay Golden Life Insurance Plan (GLIP)

It is an optional plan for those who have been BLIP members for at least six (6) years prior to reaching the age of 66. The premium of P9,950 is payable in 10 years. The coverage is up to age 100.

5. Kaagapay Credit Life Insurance Plan (CLIP)

It is a mandatory credit plan for members that offers both life and credit life insurance benefits. The premium is P1 per thousand of loan availed per week.

6. Kaagapay Mortgage Redemption Insurance (MRI)

It is a mandatory credit plan for members that covers the outstanding loan amount of the client. The premium is P10 per thousand of loan availed per year.

As she continues to serve her community, she also gains insights on how to care with sensitivity for others and their needs in times of financial distress.



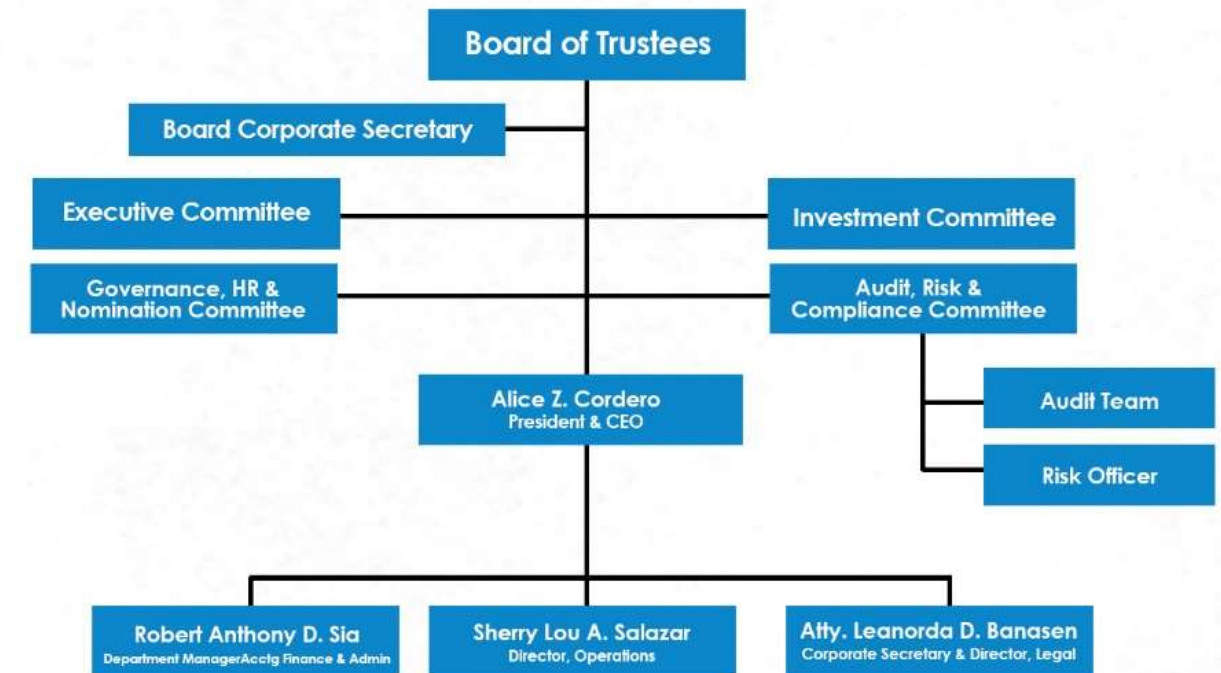
Ms. AQUILINA G. ONESA | EMPLOYEE REPRESENTATIVE (Alliance and Program Group Head)

When the COVID-19 pandemic started in the first quarter of CY 2020, TSPI Mutual Benefit Association knew that it will be a year full of challenges. Addressing the needs of members and employees to alleviate the challenges led to opportunities for TSPI MBI to better serve our members especially in the time of the "new normal".

For CY 2020, the Association focused on programs that "kept our members whole" during the Covid - 19 pandemic.



Kamustahan Program

During the onset of the Covid-19 pandemic, there was an upsurge in the use of social media. To maintain responsible contact with clients and disseminate information on how to cope with COVID-19 conditions, we immediately launched our Kamustahan Program.

Insurance Officers continued to touch base with our members via SMS or FB Chat Groups. TSPI Facebook Page posted timely information, TSPI and government announcements, health and safety campaign, Bible verses and kwentong tagumpay to provide awareness & encouragement to our members.

The Association also enhanced its customer services for members. TSPI Customer Care Services & Claims Hotline were set-up for members' easy access to TSPI and quick response to claims concerns.

As a result of the Kamustahan Program, we shifted from check disbursement to claims pay-out via GCash or deposit to bank account of beneficiaries. This move ensured that there were no claims service interruption even when the community lockdown were strictly enforced.

Unfortunately, we had confirmed 6 deaths, due to COVID and 58 COVID-related deaths as of December 31, 2020

Basic Life Insurance Plan (BLIP) Renewal at No Cost

As a compassionate response to our members whose livelihood were severely affected by the pandemic, the Association was able to secure the approval of the Insurance Commission to provide our BLIP Renewal at no cost for CY 2020.

This was to ensure that each member will have active Basic Life Insurance during the Covid-19 pandemic. Aside from members being insured for one year, they also get P120 equity value.

BLIP is the mandatory life insurance plan of the Association with a premium of Php240 per annum. It covers the member for a benefit of P10,000, the spouse for Php5,000 and up to four children below 21 years old for Php2,500 each. The insurance coverage includes death and accidental death benefits, accidental dismemberment or disablement and total and permanent disability.

For members who already paid for their P240 BLIP premium contribution last year, their BLIP will be automatically renewed for CY 2021.

P53.4 million worth of BLIP were renewed to 222,441 members at no cost. TSPI MBI processed and paid 13 claims from the BLIP Renewal at no Cost Program as of December 31, 2020

Covid-19 Health Protection Program

To help the government in its information drive on COVID -19, TSPI MBI launched the Covid-19 Health Protection Program. The objective of this program was to establish a new set of habits, routine and practices aimed at preventing the transmission of the virus.

This was achieved by providing members with essential items (face masks, soap, alcohol, disinfectant) needed during the COVID pandemic and massive information campaign on COVID 19 on how to prevent the spread of the virus.

Each item carried the following slogan and information campaign via online platform (TSPI FB page) as follows:

1. Soap: Hugas Kamay para Iwas COVID!
Health and Safety info campaign: Proper hand washing procedure
2. Face Mask: Face Mask KO Proteksyon MO; Face Mask MO Proteksyon KO!
Health and Safety Info Campaign: Who needs face mask or face covering and Why the need for social distancing?
3. Alcohol: Kaligtasan ay nasa Iyong Kamay!
Health and Safety Info Campaign: Does alcohol kill germs and viruses?
4. Disinfectants: Kalinisan ay Kaligtasan
Health and Safety Info Campaign: Proper use of disinfectants. What to do once you get home.

A total of 4,044 masks, 7,417 alcohol bottles, 6,031 soaps and 5,316 disinfectants were distributed from May to June 2020 to 14,199 member-clients.



Urban Gulayan Program

To help our members in the National Capital Region who were severely affected by the COVID – 19 pandemic, the Association partnered with Tulay sa Pag-unlad, Inc. (A Microfinance NGO) and the Department of Agriculture – Bureau of Plant Industry (DA - BPI) to ensure availability and accessibility of safe and fresh vegetables in the urban area. The project partnership was formed and represented by none other than DA Secretary William D. Dar along with BPI Director George Y. Culastre, TSPI NGO Chairman Atty. Lamberto L. Meer and President Rene E. Cristobal.

Dubbed as "Ahon Lahat, Pagkaing Sapat Kontra Covid – 19 (ALPAS COVID -19)", it created awareness on food security among urban households and promoted healthy diet by making nutritious food readily available. More so, it encouraged community sharing during harvest or provided additional income for those with big enough space that can produced enough vegetables for selling.

An online "Training on Urban Vegetable Gardening" was conducted last October 23, 2020 by DA-BPI. On November 6, the DA - BPI team headed by Mr. Ernie Lito Bollosa, BPI Training Team Assist Leader for the Urban Agriculture Program visited in the "Urban Gulayan" project areas located at the TSPI Head Office, Corporate Center and Taguig Branch. During the visit, employees and members learned the appropriate crop and planting techniques based on the size and set-up of the vegetable planting areas. Vegetable seedlings, e.g. pepper, mustard and squash were distributed by DA - BPI.



Alalay sa Kalamidad

Last November 2020, two super typhoons struck the country. Typhoon Rolly (international name Goni) has been the strongest tropical cyclone but Typhoon Ulysses (international name Vamco) had the worse impact causing the worst flooding in the National Capital Region and the Cagayan Valley Region.

To help 532 severely affected members and Kapamilya, P266,000 worth of relief goods were distributed. Beneficiaries came from the following branches:

- South Region affected by typhoon Rolly: Ligao, Tabaco, Labo, Pil (Province of Bicol) and Lucena, Mulanay and Sta Elena (Quezon Province).
- North Region affected by Thphoon Ulysses: Cabatuan, Cawayan, Ilagan and Tuguegarao.



Marketing Campaigns

The Association believes that the low-income sector who are economically vulnerable must have access to microinsurance products and services specially in this time of COVID pandemic. This is to ensure that whatever meager resources they have are protected from unfortunate events or times of difficulty.

To aid our field personnel and members to reach-out to poor communities, we have implemented several marketing campaigns.



From February to December 2020, we awarded deserving field personnel who were brave enough to conduct field visits even during pandemic ensuring each policy is renewed and new members or kapamilya have access to affordable microinsurance.

Anabelle Olarte | Bolinao Branch, Pangasinan

Ms. Anabelle Olarte joined TSPI in September 7, 2012 to finance her sari-sari store and a small piggery business.

She was remembered as a jolly and approachable person. She was well loved by her center members, neighbors and relatives.

No one knew that Nanay Anabelle was in pain as she was still happily talking with them last January 18, 2020. Little did they know that it will be the last time that they will see Nanay Anabelle. She was immediately rushed to the hospital and died on the same day due to myocardial infarction or commonly known as heart attack.

"Ganun pala ang pakiramdam ng biglaan pagkawala ng nag-iisang ina. Magkahalong lungkot at takot ang aming naramdam habang itinatakbo namin siya sa ospital at inaagapan ng paunang lunas". (I now understand the feeling of losing a mother. There was a mixed feeling of fear and deep sadness while we brought her to the hospital.) These were the words uttered by his son, John Anthony Olarte, former Account Officer of Bolinao Branch.

"Ang benepisyong nagkakahalaga ng mahigit P345,000.00 mula sa TSPI MBI ay ginamit para mapatapos ang pangarap na bahay ng aming mga magulang. Ang natira pong halaga ay pinag-hati-hatian naming apat na magkakapatid. Malaking tulong po ito sa patuloy na pag-aaral ng mga apo at makakatulong ito para mamuhay ang mga naiwan ng may kasapatan."

Aside from the settled loan balance with TSPI, the siblings were able to finish the dream house of their parents. The remaining benefits gave them hope to live a more comfortable life since they have financial resources allotted for the education of Nanay Anabelle's grandchildren. All of these somehow eased the pain that Tatay Wilfredo and the rest of the family felt due to the loss of Nanay Anabelle.

"Masakit man ang mawalan ng mahal sa buhay, ngunit sa tulong ng TSPI MBI, nabigyan kami ng pag-asa at ng kaisipan na may makakatulong sa mga oras na di inaasahan. Salamat sa Panginoon at sa TSPI! Sa kabila ng aming paghihinagpis, hindi pinabayaan ng Panginoon ang aming pamilya. Nakatanggap kami ng mga benepisyo na TSPI MBI na naging simula ng aming pamumuhay at pag-asa". (Out of our misery, the Lord did not forget us. We received benefits from TSPI MBI that allowed us to start over again and it gave us hope) – Olarte Family.

Losing someone is indeed a painful experience. But with TSPI MBI, there is hope and an assurance that the needed assistance will surely come at a time when it is most needed. Thanks to our God!

Elvira Paet | Vigan Branch, Ilocos Sur

Elvira Paet or Nanay Elvira became a widow when she was forty-nine and was left with four children. In her desire to help her children earn a decent income, she joined TSPI in September 9, 2011 at the age of 55. She borrowed P4,000 and ventured into rice vending. For more than 8 years with TSPI she was able to avail of a higher credit line due to good repayment performance. Because of her being "maalaga" (caring nature) not just to her children but also in her business, she was able to increase her capital and grow her business.

One of the many lessons she learned from TSPI was the value of savings and investment. When TSPI MBI offered a new insurance product in September 2017, she enrolled in both Life Plus and Life Max. She did not view these as expenses but as investing for the future, ensuring that her family is covered in times of financial distress. She even convinced her family and co-center members to enroll in these new product offering.

Last March 23, 2020, Nanay Elvira met an accident and fell from the Sinaguelas (Spanish plum) tree. On her fourth day of hospital confinement the doctor opted for an operation. Unfortunately, Nanay Elvira had a heart attack while undergoing operation.

Her children received more than P300,000 which was used to settle the hospital bill and funeral expenses. It was also because of this experience that her children decided to voluntarily join TSPI so they can continue the family business and get insurance coverage.

San Pablo Branch, Laguna | Flocerfida Ramos

A strong-willed and independent person, Flocerfida Ramos or Nanay Ibyang became a widow in CY 2009 and had to find ways to earn a living because she does not want to depend on her four children. In October 2014, she joined TSPI to borrow additional working capital for her fish vending business.

For more than six years of being a TSPI member, Nanay Ibyang made it a point to pay her loans on time and put it to good use. As what was shared by Sheryl, her daughter-in-law, "Kapag nanghiram ng pera dapat may napupuntahan o nakikita sa hiniram. Gamitin sa tamang paraan... sa negosyo, nang sa ganon hindi maubos ang hiniram sa walang katuturan. Bagkos dapat lumago ang hiniram na puhunan." (When you borrow money, you have to make sure that it will be properly used so that you can gain something out of it. Re-invest it in business so you can see it grow). True to her word, every money earned from her business was used to increase her working capital and she was also able to finish their humble abode.

When TSPI MBI introduced new products in CY 2017, Nanay Ibyang also availed them (Life Plus and Life Max) as she saw the advantages of these new product offering. Both product offers higher coverage than the basic life insurance plan.

Last January 19, 2020 Nanay Ibyang was rushed to the hospital but later died due to Cardio Respiratory Arrest. Since all her children were already working abroad, they all flew back to be with Nanay Ibyang. The family "reunion" became a time of mourning.

The bereaved family who received more than P200,000 from TSPI MBI used the money to settle the hospital bills and funeral expenses incurred. The rest were divided and given to her thirteen grandchildren as a small token or "pamana".
