AMENDED ARTICLES OF INCORPORATION

TULAY SA PAG-UNLAD, INC. (A Microfinance NGO)

(Formerly TULAY SA PAG-UNLAD, INC.)

KNOW ALL MEN BY THESE PRESENTS:

We, the undersigned all of whom are of legal age, majority are citizens and residents of the Philippines, have on this day voluntarily associated ourselves together for the purpose of forming a non-stock, non-profit, charitable, educational, cultural, social and civic service corporation under the laws of the Republic of the Philippines

- AND WE HEREBY CERTIFY -

FIRST

That the name of the corporation shall be -

TULAY SA PAG-UNLAD, INC. (A Microfinance NGO) (Amended May 3, 1995) (Amended on April 10, 2011 by Board of Trustees; Amended on May 30, 2011 by Members) (Amended on June 21, 2017 by Board of Trustees and Members)

SECOND - That the purposes for which this corporation is formed are:

- A. To provide access to economic, financial, social and other developmental opportunities to the small, cottage and micro-entrepreneurial sector of society and other poor and disadvantaged sectors so that they may live with dignity, sufficiency and responsibility demonstrating this through love and service in their community. (Amended on May 3, 1995)
- B. To conduct microfinance operations pursuant to R.A. 8425, the Social Reform and Poverty Alleviation Act (Amended February 3, 2006)
- C. For the realization, accomplishment and furtherance of the foregoing objectives this corporation may: (Amended February 3, 2006)
- D. Provide in accordance with law financial and non-financial service, training, workshops and seminars on various fields that may increase the entrepreneurial and financial opportunities available to the small, cottage-scale micro-entrepreneurial poor and disadvantaged such as farmers, fishermen, women, tribal minorities, urban poor and other similar sectors. (Amended on May 3, 1995)

- E. Solicit, receive, foreign or local grants, donations, endowments, bequests and legacies of any sort, to sustain the operational activities of the corporation. (Amended on May 3, 1995)
- F. To invest portions of the funds of the corporation in shares of stock bonds, time deposits and/or such projects as the Board of Trustees may determine to be advisable or proper to make more resources available to carry out the purposes of the corporation. (*Amended May 3, 1995*)
- G. To acquire, purchase, own, hold, operate, develop, lease, mortgage, pledge, exchange, sell, transfer or otherwise invest, trade or deal in real and personal property of every kind and character, or any interest therein, in any manner permitted by the laws of the Philippines. (Amended on May 3, 1995)
- H. Open bank accounts with any bank, secure or incur credit or financing facilities with any bank, credit institution or with any person, whether natural or juridical.
- I. Organize a principal office, branch office, buildings, stores, bodegas or improvements anywhere in the Philippines that may be necessary in carrying out the purposes or objectives for which this corporation was organized.
- J. To take such steps, make personal or written appeals, conduct public meetings or otherwise, as may from time to time be deemed expedient in proposing enactment or changes in legislation, government policies, and other similar advocacy work for the improvement of basic services and availability of social and financial opportunities to the small, cottage scale and micro entrepreneurial sector as well as other poor and disadvantaged sectors of the Filipino society. (Amended on May 3, 1995)
- K. In general, to exercise any and all lawful powers whatsoever in connection with the foregoing or which are calculated directly or indirectly, to promote the interest of the corporation or to enhance the value of its properties and to perform everything necessary and proper for the attainment of its purpose. (Amended on May 3, 1995)
- THIRD That none of the net earnings, profits or income of this corporation shall inure to the benefit of any member, trustee, director or officer of the corporation.
- FOURTH That the level of administrative expenses of this corporation shall in no case exceed thirty percent (30%) of the total donations

received and of total expenses for any taxable year. (Amended on May 25, 2009)

FIFTH - That the principal office of the corporation shall be located at No. 2363 Antipolo Street, Guadalupe Nuevo, Makati City, Metro Manila, Philippines. (Amended on November 5, 2014 by Board of Trustees; Amended on December 3, 2014 by Members)

SIXTH - That the term for which this corporation is to exist shall be fifty (50) years from and after the date of incorporation hereof, renewable for another fifty (50) years pursuant to existing laws in this jurisdiction.

That the assets of the corporation, in the event of dissolution, would be distributed to another non-profit domestic corporation organized for similar purpose or purposes, or to the state for public purpose, or would be distributed by a court to another organization to be used in such manner as in the judgment of said court shall best accomplish the general purpose for which the dissolved organization was organized. (Amended on May 25, 2009)

Amendment on the other regular remaining articles shall only require a majority vote of the members of the Board of Trustees and majority vote of the members of the association at regular or any meeting. Provided, notice of the proposed amendments shall be distributed or sent to the residence or usual place of business of every member at least ten (10) days before the (Amended on April 10, 2011 by Board of Trustees; Amended on May *30, 2011 by Members)*

That Mr. Aurelio C. Llenado, Jr. has been elected by the members of the Board of Trustees as Treasurer of the corporation until his successor is duly elected and qualified in accordance with the By-Laws. As Treasurer he is authorized to receive for the aforesaid all funds, properties, and effects contributed or acquired to sustain the maintenance and operational activities of said corporation.
