OUR STORY

Tulay sa Pag-unlad, Inc. (TSPI) formerly TSPI Development Corporation, was established on October 30, 1981 as the pioneer of the Philippines' microfinance industry by Maranatha Trust founded by businessman David T. Bussau. It is a Christian, non-stock, non-profit microfinance NGO engaged in social development programs and services to fulfill Christ's commission to proclaim the Good News of His saving grace and kindness to the poor. In partnership with other institutions, it works towards poverty alleviation by supporting the livelihood of microentrepreneurs, agropreneurs, and communities of indigenous people. Along with being beneficiaries of social services programs, their spiritual well being is also nurtured. TSPI believes that these microenterprises and farms are God's blessings to the clients and their bridge to progress (tulay sa pag-unlad).

As of December 31, 2024, TSPI had served 152, 031 clients through its 119 branches with 116 Sambayanihan Centers all over Luzon. TSPI has a total asset of P1.29 Billion and total loan portfolio funds of P1.07 Billion.

PROGRAMS & **SOCIAL SERVICES**

TSPI NGO continues to provide working capital for microentrepreneurs through livelihood loan programs. Through its microinsurance arm, TSPI Mutual Benefit Association Inc. (MBAI), TSPI NGO's clients and employees are also given access to microinsurance and credit life insurance.



TSPI Kabuhayan Program (TKP):

For individuals with livelihood/microenterprise operatina for at least 3 months. committed to collective responsibility, we provide collateral-free loans of up to Php 50K, payable up to 6 months on a weekly basis.



TSPI Mauniad Program (TMP):

For businesses operating for at least two (2) years with a minimum capital of Php 60K, we offer loans from Php 50.001 to Php300K, payable up to 3 to 24 months on a monthly basis.



TSPI Programang Pang-Agrikultura (TPP):

For agropreneurs committed to collective responsibility, agri-loans are provided to individuals up to Php150K for a maximum of five hectares. For an agropreneur group, Php300K is the maximum loan amount. The loan is payable in lump sum at the end of the cropping season for rice and corn within 12 months. For highvalue crops, the loan is payable in four (4) to six (6) months on a monthly basis.



For housing improvement, water source installation, and electrical connection, we offer this program to clients with existing business loans (TKP, TMP, TPP) payable in 6 to 12 months with weekly repayment.



Education Loan Assistance Program (ELAP)

For clients' children and immediate family members in pre-elementary to post-graduate levels or taking special courses, TSPI NGO offers offer loans of up to Php20K to clients with existing business loans, payable in three (3) to six (6) months with weekly repayment.



Microinsurance and Credit Life Insurance Program (CLIP):

TSPI Mutual Benefit Association, Inc. (TSPI MBAI) offers highly affordable microinsurance plans for TSPI clients, employees, and their immediate family members.

The initial 40 Sambayanihan Centers, used as special places to encounter God and to conduct social services, substantially increased to 116. This way, we are able to make others feel blessed with our generosity.

YEAR-END REPORT

2024: A Year of Responsible Growth, Stronger Partnerships, and Focused Service

As TSPI marked its 44th year of transforming the lives of Filipino micro entrepreneurs, families, and their communities, we remain humbled by God's faithfulness that has sustained us through every season. Across all these decades, God's grace has been our consistent source of strength, enabling us to remain steadfast in our mission even amid challenges and change.

Guided by Christ's example of loving kindness to the poor, TSPI continued to support clients through financial and social development programs, and the nurturing of their spiritual well-being. We took to heart this calling to uplift lives holistically, bringing transformation to families and communities that we serve.

Stewardship, Synergy, and Simplicity in Service

TSPI remains deeply mindful that every resource entrusted to us is a gift: a sacred responsibility to be managed with integrity, accountability, and care. As stewards of these resources, we are committed to using them wisely and purposefully, not only to **uplift the lives of our colleagues and clients** but also to **reflect and share the love of God** in all that we do.

Our journey reminds us of the power of working together. With **synergy**, impact is multiplied beyond what we can accomplish on our own. In 2024, TSPI continued to **strengthen strategic partnerships** through collaborative initiatives that reflect its commitment to wholistic transformation and inclusive growth. In partnership with the **Wholistic Transformation Resource Center**, TSPI supported Kasalang Bayan in Antipolo, a values formation initiative under the Sambayanihan Program. This activity sponsored members seeking to formalize their unions—removing barriers related to documentation and coordinating with concerned institutions. The initiative emphasized marriage as a sacred commitment and a key foundation for strong, resilient families.

In the area of sustainable agriculture, TSPI's Farmers' Entrepreneurship Program (FEP), in collaboration with the **Jollibee Group Foundation**, helped our farmers belonging to five (5) various farmer groups to achieve individual **Philippine Good Agricultural Practices (PhilGAP)** certification. These recognitions, conferred by the Department of Agriculture, affirmed the program's impact in promoting safe, responsible, and market-oriented farming.

TSPI also advanced knowledge-sharing efforts and strengthened local partnerships to support livelihood development. During Women's Month, it partnered with **Standard Chartered Bank** for the Babae, Bilang Negosyante seminar in Tondo, equipping 59 women with essential business skills and entrepreneurial tools. TSPI was also honored by the **local government of San Manuel**, **Tarlac**, as an Outstanding Partner for supporting white onion farmer groups now supplying major markets such as **Jollibee Foods Corporation**. Further recognition came during the 2024 Labor Day Festival in **llocos Sur**, where TSPI was commended for its participation in job fairs and local economic development activities. These collaborative efforts underscore the value of synergy in achieving shared goals and driving measurable, community-based outcomes.

Anchored on the principle of **simplicity**—serving individuals with simple dreams—TSPI continued to invest in **digital transformation** to simplify processes, increase operational efficiency, and improve service delivery. The organization's long-standing commitment to **financial inclusion** took a significant leap forward in 2024, building on its multi-year digital roadmap. TSPI scaled the deployment of its mobile and online platform, TSPI CLICK Plus, giving clients real-time access to loan accounts, insurance, and Capital Build-Up (CBU) services from the comfort of their homes. The tool empowered account officers to process reloan applications more efficiently, freeing up time for fieldwork, business development, and client support. With the integration of INSTAFIN core banking and a strategic migration to Google Workspace and TRACES for secure cloud-based collaboration, TSPI ensured seamless communication, enhanced data access, and greater staff productivity across 119 branches and 116 Sambayanihan Centers nationwide.

These efforts translated into reduced turnaround times, from five days to one, while **decreasing operating costs** and **improving gross revenues**. Digital processes also created **opportunities** for internal capacity-building and **career development**, with eligible staff receiving compensation adjustments ranging from 30% to 50%. Training programs enabled digital champions within the organization to cascade knowledge and support end-users, including clients and agents.

For these efforts, TSPI was recognized as a **Digital Champion in the Microfinance Institution (MFI) Category** at the **3rd Digital Financial Inclusion Awards (DFIA)**, validating its vision of combining innovation with purpose. TSPI remains resolute in expanding its digital capabilities by embracing automation and cloud-based technologies to ensure that even the simplest dreams of the underserved can be realized through efficient, client-centric service.

Financial Performance and Key Strategies

At the end of 2024, total loan releases, composed of livelihood loan programs and social welfare loan programs, were at PhP 1.97 Billion, compared to PhP 2.45 Billion in 2023.

Net income stood at PhP 4.88 Million versus PhP 21.39 Million in 2023. Client outreach was at 152,031, with only a slight decrease from 177,624 in 2023. Total assets were valued at PhP1.29 Billion and Php 1.30 Billion for 2024 and 2023, respectively. Total loan portfolio funds at PhP 1.07 Billion in 2023 remained the same for 2024.

To enhance overall performance, TSPI is adopting an integrated strategy focusing on these key areas: growth, performance, and operational efficiency.

Driving growth. One of the priorities is the implementation of a 70-30 strategy, with 70% of efforts directed toward improving productivity by increasing the number of new clients, and 30% focused on reducing the Portfolio-at-Risk (PAR). This approach ensures sustainable growth while maintaining the financial health of the organization.

To support this growth, TSPI is enhancing the visibility of products and services via Facebook, with the aim of increasing awareness, engaging potential clients, and building a stronger presence in the digital space.

TSPI has **established Digi-Center** to introduce solutions to promptly serve clients who have yet to be assigned to an existing center. This allows for faster onboarding and a better client experience.

To further encourage loan availment and community engagement, TSPI is actively implementing the **Sambayanihan Programs**, initiatives aimed at attracting new clients through various activities.

Continuous **sustainability programs** are also important for driving long-term company growth especially in a rapidly changing business landscape. These are being done through valuable partnerships, PAR (Poverty Alleviation Recovery) Healing Program and Sambayanihan Centers.

Valuable partnerships with local and global entities provide Special Loan Programs. These collaborations help acquire new clients, offer new digi-based livelihood programs and launch new social media campaigns, which reach out to more employees, clients and partners. In addition, lower interest rate is offered with defined customer base supported by capacity-building training. PAR Healing Program is TSPI's way of God-centeredness of embracing clients with long outstanding loan dues to overcome financial challenges attributed to national state of calamities - typhoons, flooding linked to climate change, national disasters, volcanic eruptions, lingering health problems, slowdown of economic activities and need for clients to shift doing business via digitalization. And the Sambayanihan Centers are part of TSPI's aspiration to properly respond to client needs with structured, transformation programs, sustainable social services and delivery of digital knowledge to augment livelihood income.

Strengthening performance. TSPI is aiming at **employee career development** and providing opportunities to enhance organizational impact. By investing in training, mentorship, and career growth, TSPI intends to improve employee skills, boost morale, and increase productivity.

Training and mentoring help increase employee engagement and encourage **a culture of continuous learning**, which could lead to higher productivity and profitability. Both are also significant factors in the implementation of effective succession planning. This contributes to developing internal talent within TSPI, facilitating knowledge transfer, and fostering affirmative leadership practices. Such form of guidance enables potential successors to acquire essential skills, knowledge, and the confidence to seamlessly transition into leadership roles, ensuring business continuity and improved performance.

Incentives are also offered to both employees and clients based on accomplishments. These rewards are meant to build motivation, encourage results, and reinforce a performance-driven culture. With incentivizing, the following could beneficially impact TSPI's effectiveness: higher volume, positive word-of-mouth marketing through referrals, customer base expansion and employee retention.

Enhancing operational efficiency. To ensure the delivery of quality service from day one, TSPI is enhancing its training program for probationary field staff, equipping them with the tools and knowledge needed to succeed in their roles.

The newly created **Credit Cycle Management Department (CCMD)** will handle telemarketing and tele-collection to help generate new leads and boost loan outreach. These are meant to increase sales by enhancing customer engagement, lead generation, and debt recovery.

These **strategies** are all about empowering TSPI to grow into a stronger, more responsive organization that truly listens to the needs of our clients, supports our staff, and remains ready to serve communities with compassion and commitment.

TSPI Transformation Framework

Under the leadership of our Senior Management and Board of Trustees, we remain focused on our mission of stewardship, where each of us is called to act with purpose, embracing our role and responsibilities as faithful stewards.

At the heart of TSPI is its **Transformation Framework**—a living embodiment of our commitment to uplift the lives of our clients as well as our employees with their families and communities. We continue to witness and build upon our Transformation Framework to sustain TSPI's programs and services, and ensure that the organization continues to flourish and bear meaningful fruit.

Rooted in **God-centeredness**, TSPI's Transformation Framework aims to develop God-fearing and socially responsible micro entrepreneurs and agropreneurs. Our core values of Stewardship, Integrity, Servanthood, and Excellence keep alive the spirit and purpose of our work across communities.

The four elements of the TSPI Transformation Framework with TSPI Transformation in Action are: economic sufficiency, client competency, financial probity, and relational maturity.

Economic sufficiency is achieved by providing access to sustainable livelihood loan programs through micro-loans, micro-savings, micro-insurance and other basic services such as healthcare, housing and sanitation loans leading to their financial stability.

Member client competency is enhanced through capacity-building programs focused on financial literacy, business skills, and decision-making ability. These initiatives equip participants with practical knowledge and tools to better manage finances, grow their enterprises, and make informed choices for long-term sustainability.

Financial probity is strengthened through lending programs integrated with values formation, safety nets, and food security initiatives. These are designed to instill credit and savings discipline while promoting ethical business practices, fostering a more responsible approach to livelihood development.

Relational maturity is acquired when clients have deepened their relationship with God, strengthened family ties, and built meaningful connections within their communities. This transformation promotes wholistic personal growth rooted in faith and shared values as being taught in the TSPI discipleship program.

The impact of the Transformation Framework on the lives of clients, their families, and communities is what drives the sustainability of TSPI's programs and services.















A. Livelihood Loan Programs (As of December 2024)

Re-igniting Our Mission at the TSPI Operations Leadership Conference 2024



TSPI successfully held its Operations Leadership Conference 2024 at **Mount Purro Nature Reserve** on June 21-23, 2024. It brought together leaders and team members from across the organization for three days of reflection and reconnection. With the theme "**Stewardship**, **Synergy**, **Simplicity**: **Re-igniting Our Mission**," the conference focused on the spiritual and operational principles that continue to strengthen TSPI's mission.

The event opened with reflections on **Christ-centered leadership**, reminding participants that true leadership is a lifestyle rooted in a relationship with Jesus and marked by humility, faithfulness, and service.

A discussion reinforcing TSPI's mission emphasized the importance of experiencing the fullness of life in Christ through Christian microenterprise development. As we help clients start or grow their businesses, we also **show and share the love of Christ** with them while helping them develop strong character and values.

This underscored the role of TSPI as **a good steward**: recognizing that everything we have comes from God and using it in a way that honors Him. We always use time, talents, and resources for the service of God.

Succeeding sessions highlighted the core values of **Excellence**, **Integrity**, **Stewardship**, **and Servanthood**, urging leaders to align personal goals with organizational purpose. With emphasis on synergy and Christ-like accountability, the talks called everyone to lead with faith.

Stewardship calls us to faithfully manage what God has entrusted to us—time, skills, and resources—with a heart that seeks to honor Him and uplift others. Throughout the conference, breakout group sessions provided opportunities for honest sharing and deeper insights on our respective experiences, reinforcing our mission of stewardship and **shared purpose**.

Leading with TRUST

"The spirit of commitment is alive," said Executive Director Alice Z. Cordero as she addressed TSPI's leaders. She reminded everyone that when it comes to faith, TSPI is unwaveringly Christ-centered.

As the organization continues to grow and serve more communities, Ms. Cordero encouraged leaders to embody TRUST: be **Transparent**, **Risk-conscious**, have **Unity** of decisions, be grounded in **Stewardship**, and always ready to **Take Responsibility**.

"When you don't know what to do next [in certain situations], just think TRUST GOD," she advised.

Ms. Cordero also urged TSPI leaders to stay disciplined and open to growth, especially through digitalization and improved systems. "At TSPI, we are very liquid, with no borrowings because we've empowered our clients to save, to build, and to give back," she said, citing the 50% portfolio now funded by microsavings.

She reminded everyone that **discipline and discipleship** go hand in hand, and that obedience—whether to policies or to God's plan—is a form of love. "Our concept of discipleship is unique. We find happiness in everything we do. Discipline must be embraced by everyone, because it includes respect to corporate standards," she said.

In closing, she gently challenged everyone to keep trusting in God's purpose: "God's not giving up on you. Don't give up either. At the end of the day, we just want to experience the love of God."

Near Neighbors

On March 14, 2024, TSPI Chairman Emeritus - David Bussau together with TSPI Executive Director Alice Cordero, Executive Director and TSPI Board of Trustee Toto Malvar visited the Tondo Sambayanihan Center hosted by the **San Miguel Foundation's Better World Smokey Mountain (BWSM)** in Brgy. 128, Balut, Tondo, Manila.

It was a day well-spent in dialogue with San Miguel Corporation Vice President and San Miguel Foundation Executive Director Kin Lichauco.

Built by SMC, the building is located in the middle of 30 tenement buildings and located beside the Estero de Vitas. It hosts five organizations, **as co-partners**, with the same purpose: to help people in the name of God.

- AHA Learning Center, represented by Teacher EJ Lapira, Managing Director, teaches children.
- Upskills+ Foundation Inc., represented by Mary Rose Armario, Project Lead, provides livelihood opportunities.
- **Project Pearls**, represented by Jonalyn Andia, a community mothers, gives livelihood opportunities and scholarships to children who lack the means to finish their studies.
- Sandiwaan Center for Learning, represented by Fr. Benigno Beltran, Executive Director, conducts Alternative Learning System (ALS) training for working students and out-of-school youth.
- TSPI.

Mr. Bussau spoke with seven TSPI clients who proudly told him about their various businesses. One of them, Gina Antonio, a TSPI client for 14 years, has supported her four sons mainly from earnings of her streetfood business. She has been running her business for 12 years. The 44 year-old widow had to pivot during the COVID outbreak. After the pandemic, she was able to resume stall operations at a busy section within her community.

Lolita Estinor, 63, has been a TSPI client for eight years. The mother of four has been running a junk shop in Tondo for all 30 years that she has resided there. Jovy Angeles, 57, has been running a sari-sari store for seven years and has been a TSPI client for 14 years.

They were animated as they how more people in the community were earning from their entrepreneurial endeavors, especially those who benefited from microinsurance claims. These were used for their homes and businesses—to improve their living conditions.

In the face of all of these bright spots, TSPI's Sambayanihan Programs will further extend to serve more communities in Tondo.

TSPI Farmer Groups Honored for Agricultural Excellence

On September 6, 2024, five farmer groups who are part of the TSPI's Farmers' Entrepreneurship Program (FEP) were recognized during the "Regional Awarding and Recognition of PhilGAP Certified Farms in Central Luzon." Held at the Heroes Hall in the City of San Fernando, Pampanga, the event celebrated the commitment of farmers to uphold sustainable and safe agricultural practices.

The Department of Agriculture-Regional Field Office III's Regulatory Division bestowed the prestigious recognition on farms that have successfully earned the **Philippine Good Agricultural Practices (PhilGAP) Certification**. Administered by the Bureau of Plant Industry (BPI), this certification upholds the integrity of food safety, environmental care, and public health.

The following groups received their awards: MASIFAGCA (Magsalisi Farmers and Growers of Calamansi) from Jaen, Nueva Ecija; Tucop Farmers Association from Tucop, Dinalupihan, Bataan; Marcos Villagers' Palayan City Farmers Agrifarm Corporation from Palayan City, Nueva Ecija; Pagbiagan Multipurpose Cooperative from Mataranoc, San Manuel, Tarlac; and Ungab Farmers' Association from Cuyapo, Nueva Ecija.

TSPI North Central Sector Head Lorena Mandanas and Area Manager Maricel Venturina represented the firm during the ceremony. Their presence underscored the vital support that TSPI plays in empowering smallholder farmers with financial assistance, entrepreneurial guidance, capacity-building, and advocacy for sustainable practices.

At the heart of this celebration is **synergy**—the dynamic interaction between TSPI, the farmers, and government institutions. With valuable support from the **Jollibee Group Foundation** (**JGF**), TSPI's Farmers Entrepreneurship Program acts as a bridge, linking farmers with critical resources and knowledge **to thrive in modern agriculture.** The farmers bring their dedication, expertise, and willingness to innovate, while government agencies like the Department of Agriculture provide guidance and recognition that validate their efforts.

Sixty year-old Emmie Marques Macaso has always lived in Jaen. Her husband was initially the farmer in the family. Eventually, she and her son also took on farming. Currently, she is the owner of Emelita's Farm and also serves as president of MASIFAGCA. She has been a TSPI client since 2018. When the MASIFAGCA farmer group started attending **training sessions sponsored by JGF**, she admits, they were unsure if they could meet the criteria for farm-partners set by **Jollibee Food Corporation(JFC)**. However, when they found out that they were chosen among the fastfood's preferred suppliers, she was elated.

In meeting the **PhilGAP** requirements, she admits that the learning curve was steep, since many of their farmer members were already set in their ways, and they were unsure how getting certified would benefit them. Still, they appreciated the shift in practices and mindsets because this led them to adapt better farming practices. "The reason we sought certification was because Jollibee requested it, since we were dealing with food, something that people will consume. It was a big help because we now value what inputs go into planting food items. They gave us the opportunity to improve, "she said in Tagalog.

The awards serve as a validation for the farmers as well as an inspiration for other farmers to pursue similar certifications, thereby raising the overall standard of Philippine agriculture.

The recognition is a **testament** to what can be achieved when **purpose-driven organizations and dedicated individuals work** hand-in-hand toward a **common goal**.

Partnerships for sustainable agriculture

On February 25, 2024, TSPI was honored as an Outstanding Partner of the Local Government Unit (LGU) of San Manuel, Tarlac, during the town's 115th Founding Anniversary celebration. TSPI's support has helped mobilize farmer groups and strengthen their economic resilience. Five accredited farmer groups in San Manuel now supply white onions to Jollibee Foods Corporation, namely: Pagbiagan Multi-Purpose Cooperative, Ungab Association, Segundu Association, Marcos Association, and Tucop Association. This achievement marks a significant step toward making their agri-business ventures sustainable and marketdriven.

Sixty year-old Eulogio Cabiles has been a farmer for 40 years in San Manuel, Tarlac. He has farmed rice, tobacco, and corn. In 2014, he received the National Gawad Saka Award as Outstanding Corn Farmer from the Department of Agriculture.

In 2023, he attended TSPI's Farmer Entrepreneurship Program. He is also president of the Pagbiagan Multi-Purpose Cooperative, which was awarded 2nd Outstanding Cooperative by the Provincial Government of Tarlac in January 2024. Cabiles attests to how TSPI linkage with Jollibee has helped improve the lives of members. "In the past, when we dealt with traders, they would drive the prices very low, without regard to the welfare of farmers. But since we have been supplying white onions to Jollibee, we have been treated fairly. They consider our cost of production and add twenty percent, regardless of the prevailing farmgate price, "he said, in Tagalog. In fact, many farmer members have been able to renovate their bamboo houses to concrete ones and fund the education of their children. Some have even purchased their own motorcycles. "The farmers are

very happy! "Cabiles said.

This success highlights the **power of synergy**—where TSPI, local government, and private sector collaboration converge to produce tangible results in the agriculture sector. By empowering farmers with access to financial tools and viable market linkages, TSPI helps transform subsistence livelihoods into thriving, community-based enterprises.

Partnerships for community development

TSPI's dedication to inclusive economic growth was also celebrated during the **2024 Labor Day Festival** held on May 1 in Vigan City, Ilocos Sur. Held at the Provincial Farmer's Livelihood **Development Center**, the event had the theme, "Sa Bagong Pilipinas: Manggagawang Pilipino, Kabalikat at Kasama sa Pagasenso." TSPI was commended for its proactive involvement in local initiatives and was awarded three recognitions: for sponsoring the "Hiring on the Spot" segment at the 7th One llocos Sur Job Fair on March 22, 2024; for its participation as a hiring employer during the 2024 Labor Day Job Fair; and for its support of the Local Economic Development (LED) Activity during the 8th One Ilocos Sur Job Fair.

By taking part in job fairs like these, TSPI opens employment opportunities and also strengthens the local economic fabric. As one of 30 companies and organizations that participated, TSPI's commitment to hiring local talent reinforces its role as a partner in sustainable development and social impact.

Synergy for Health

Believing that our bodies are temples of the Holy Spirit, TSPI continues to uphold the importance of health through its Sambayanihan Program. In coordination with the Dr. Nicanor D. Montoya Foundation Inc., medical missions were conducted to deliver primary medical care in order to address health needs in underserved communities.

On October 10, 2024, TSPI hosted a successful medical mission for 570 beneficiaries at TSPI's Sambayanihan Center in Bray. San Francisco, Bugallon, Pangasinan. This initiative united efforts from the Local Government Unit of Bugallon, Barangay San Francisco, and the Federation of Christian and Muslim Volunteers Brigade Cops Rescue-Bugallon Chapter.

The TSPI Employees' Cooperative also distributed hygiene kits to 50 children, while storytelling sessions led by Pastora Mar Yaneza of the Passion of Christ Church Inc. of Lingayen brought joy and inspiration.

Meanwhile, the TSPI Vigan Branch organized a Medical Mission on Oct. 11, 2024 at the Caoayan Auditorium in Caoayan, Ilocos Sur. About 606 persons from nearby barangays availed of the free medical services.





TSPI Vigan Branch Manager Monika Mendoza and HR Specialist Cristina Oribello conducted a Bible study and Hygiene Orientation for children. They also distributed 60 hygiene kits sponsored by the TSPI Employees' Cooperative.

This was an overwhelming success due to the combined efforts of TSPI and various organizations in llocos Sur: the Caoayan Local Government Unit, Caoayan Regional Health Unit Medical Team led by Dra. Edna Rabena and nurses, Barangay Health Workers of Callaguip and Anonang Menor (both in the municipality of Caoayan), and Ora West in Bantay.

The following medical professionals from the Dr. Nicanor D. Montoya Foundation Inc. shared their time and expertise for these medical missions: Dr. Voltaire Victoria, Dr. Agnes Vargas, Dr. Virgie Pascua, Dr. Fernando Peraldo, Dr. Juliet Recidoro, pharmacists Cristina Ambrosio and Beng Esteves, nurse Romeo Dilag, and ophthalmologist AJ Caponpon.

The event provided free medical consultations, medicines, supplements, and eyealasses. Beyond healthcare, the missions also extended their impact with free haircuts, feeding programs, and job fairs.

This medical mission highlights TSPI's commitment to wholistic development by fostering physical, spiritual, and social well-being. Through meaningful collaboration and shared faith in action, TSPI and its partners continue to bring vital services to communities in need, affirming that caring for the body is a sacred duty.


Empowering Communities

In its mission to serve the marginalized and uplift Filipino families through its various services, TSPI initiated—and continues to pursue – **a bold digital transformation journey** driven by a **commitment** to enhance service delivery and empower both their clients and employees.

The status quo, while effective in the past, would be insufficient to meet the evolving needs of our growing client base. Many of TSPI's clients, especially in rural areas, faced challenges in accessing timely financial services. The hassles of travelling, hefty expenses, long wait times, and limited communication channels hindered clients from making the most of the opportunities available from TSPI.

Motivated by the desire to serve them better, TSPI launched a **comprehensive assessment** of its systems and developed a multi-year **digital roadmap** for digital transformation. With the support of dedicated partners and stakeholders, TSPI began upgrading its systems and rolling out mobile and online platforms that allowed clients to access loan services, monitor repayments, and maximize other features—anytime and anywhere.

TSPI's Digitalization Journey:



Since 2000, TSPI has invested in sustainable digital transformation programs in IT advancement with 11 major systems of which seven (7) systems are TSPI in-house developed.

TSPI manages 6 social media accounts - Facebook, FB Marketplace, Operations FB Group, YouTube and Google Workspace.

In 2000, TSPI took the first step in its commitment to adopt digital solutions by implementing the **E-Banker Core System**. This laid the groundwork for all future advancements.

Since 2000, TSPI has invested in sustainable digital transformation programs in Information Technology advancement with 11 major systems, of which seven systems were developed in-house. TSPI In-house systems are: TSPI Optimize Program System (TOPS), Branch Attendance Monitoring Systems (BAMS), TSPI Portal, TXTBilis (SMS Facility System), Finance AGFP Claims and Enrollment System (FACES) now called Treasury AGFP Claims and Enrollment System (TRACES), TSPI Agent Account System (TAAS) Mobile App, and TSPI Check, Loan, Insurance, Capital Build-Up, Kaagad (CLICK). Almost every 10 years, TSPI implemented digital core systems namely: **E-banker, Polaris** and **Instafin.**

- 2014 TSPI developed an in-house micro insurance system for its Mutual Benefit Association (MBAI), called MBA Polaris System, which resulted in proper monitoring of member enrollment by those who avail of micro insurance.
- **2015 TSPI TAAS** mobile application, automating the posting of client's payment through the accredited agent partners, supervised by TSPI Account Officers.
- 2022 TSPI launched TSPI CLICK, a comprehensive web and mobile application that provides easy access for clients and staff 24/7 anywhere; purpose is to manage loans, CBUs, and insurance information for accounts and insurance policies to remain current and active, respectively.
- 2023 TSPI CLICK was upgraded to TSPI CLICK plus, which allows existing clients to apply for loans directly through the platform.
- 2024 TRACES, an internal reporting system that has been enhanced and fully integrated with the Agricultural Guarantee Fund Pool for monthly collection of payment from farmers. TSPI employees have access to their own Google Workspace, which has vastly improved internal communications.

As a result of its digital transformation efforts, TSPI was awarded at the **2022 GCash Digital Excellence Awards** in pioneering digital finance programs and **Digital Champions - MFI Category** at the Third Digital Financial Inclusion Awards last December 2024.

As of Dec 31, 2024, TSPI's digital footprint extended to 119 branches and 116 Sambayanihan centers–all of which make full use of these innovative systems.

All of these endeavors are motivated by TSPI's care for clients and employees. Without the hassle of spending time and money to personally appear at the TSPI branch, clients are able to make better use of their resources. The CLICK app gives them better access to their accounts.

Digitalization has freed up time spent by employees on tedious paperwork to focus on **quality time** with their families. The training that they received has also leveled up their skills and expanded career growth opportunities which could be translated into an increase in employee compensation ranging from 30% to 50%.

TSPI is unwaveringly committed to stay ahead of digital transformation to empower more Filipinos with knowledge and aptitude in making full use of technological advancements.

More innovations will be undertaken to modernize systems and to provide better, **more efficient service** for the benefit of transforming the lives of staff and clients. Moving forward, one of the most-awaited initiatives in digitalization is the upgraded version of TSPI CLICK plus on which the **Devotion**, **Outreach**, **Values formation and Empowerment (DOVE)** transformational tool will be embedded. Clients will have easy access to devotional and inspiring e-materials. It is with great hope as they learn from DOVE, they will be able to put their learnings into practice and eventually **empower their communities**.

Beyond Meeting Needs:

Nanay Gina Antonio and Nanay Jessica Lavarias

Food is a basic human need. With assistance from TSPI, two of its women clients meet this need and have exceeded expectations to enrich their own lives and those around them as well.

Rising from challenges

Forty-four year-old Nanay Gina Antonio of Tondo, Manila has been a client of TSPI Tondo Branch since 2011. At the time, she and her husband took out an **initial loan of P8,000** to engage in a junk shop business, ferrying scraps daily between Cavite and Caloocan using the motorcycle they purchased using some of the loan amount. However, this business failed because they were unable to assess the impact of expenses on their initial investment.

Nevertheless, their persevering spirit prevailed; soon, the couple **embarked on a new endeavor**. Nanay Gina used the remaining savings of P4,000 to start a street food stall in their community. It was a fortuitous move since their neighborhood, Barangay 128, located in what used to be Smokey Mountain, is densely populated. It is always bustling with people who need to satisfy their need for food. In no time, she built a loyal customers base who kept her stall busy.

In 2018, Nanay Gina's life greatly changed. Her husband, Manuel, passed away after a road accident. Nanay Gina was left to care for four young sons on her own. She was devastated by the sudden loss. After a period of grieving, **she was determined** to do her utmost to provide for her sons' needs and those of her own. The funds she received from TSPI, her husband's insurance benefit of P60,000 and P20,000 working capital, eased the financial burden.

She needed to **stand strong** for her family, thus, she focused more on her business. Her neighbors regularly bought street food lovingly prepared by Nanay Gina. She sold it consistently throughout the day, every day without fail.

When the pandemic hit, she had to close up shop due to social distancing measures to avoid the spread of the virus. Nanay Gina eventually found a way to **augment her income** by selling eggs and loaves of bread to her neighbors. By doing this, she was able to earn a living and adhere to health protocols at the same time.

In 2021, when pandemic restrictions started to ease, Nanay Gina slowly restarted her streetfood stall with P20,000. She expanded her menu to include halo-halo (in which the ingredients are proudly homemade). This resulted in lower investment margins and **higher profits** for Nanay Gina. She has also branched out to serving bulk orders of "kakanin" or rice cakes like "puto" and "sapin-sapin" online. Nanay Gina leverages **grit** and **determination** to grow her business. There may be days when sales are low; however, she strongly believes that nothing is beyond the reach of **someone who believes in her own capabilities and thinks positively**. Hence, she greets every day and her customers with a smile.

What Nanay Gina earns supports herself and her three children who are still in school: one in college and two in elementary school. As a responsible mother, she is willing to sacrifice everything for her children to have **a brighter future**, a simple yet profound dream that every Nanay in TSPI would want to achieve.

Expanding a simple idea

Meanwhile, Nanay Jessica Lavarias of Calasiao, Pangasinan has been a TSPI client for 14 years.

She has always been **resourceful**. Her husband lost his job at a restaurant during the pandemic, so they started a small food business in July 2020, selling two items fresh lumpia and chili oil under the name El Bonita's Canteen. They built a modest following at first, thanks to product quality and consistency.

By September 2020, Nanay Jessica tapped **social media marketing**; need met opportunity and her client base ballooned. From 15 customers per day, El Bonita's Special started averaging 50 customers per day. She has also expanded menu offerings to include various food items to satisfy the diverse tastes of her market.

Now, she averages 150 customers, 30 percent of whom are online customers. Aside from social media, online payment options also vastly helped her business arow and thrive.

In addition, Nanay Jessica now **employs more than a dozen staff members** to meet the demands of her flourishing business. To share the benefits with her neighbors, she hires them to deliver the food orders to clients. Her **generosity** extends to those around her, based on her strong faith.

Beyond her neighborhood, Nanay Jessica **conducts outreach activities** for those in need. She shares her blessings by engaging in various socio-civic projects, including **feeding programs** in various places and **offering financial assistance** to disadvantaged youth in her locality who are pursuing their studies.

Lessons learned

"Kailangan lang ay sipag at tiyaga. Kahit anong pagsubok, kailangan lang ay tatag ng loob at self-confidence na kaya mong malampasan ang lahat. (All you need is **diligence** and **perseverance**. Any challenge, you can overcome with **fortitude** and **confidence** that you will rise above it.)" Nanay Gina said.

Nanay Jessica, who won at the **Digital Financial Inclusion Awards** under the **Microentrepreneur Category** in 2024 is motivated to help her neighbors, both near and far. "Sabi ko sa Diyos, yung binigay niya sa amin na business ay unexpected blessing talaga. (I told the Lord, this business is an unexpected blessing given to us.)"

These women have shown great resolve in pursuing a **dignified way of living** and **providing for their families**. They have used their resourcefulness and relied on their faith to overcome challenges. They also **walk daily** in faith to make the most of their situation in life, remembering **Christ's commission** to love our neighbors.

Nanay Gina and Nanay Jessica are examples of TSPI clients who embody the value of **Stewardship**. Provided resources **thrived under their care**, benefitting themselves and those around them. They are typical micro entrepreneurs who have **simple dreams**: a **better future for their families** and **inspiration to uplift people** that surround them, **beyond meeting their needs**.
